What's Provided

Childcare and early years education is offered 7am – 6pm all year round (minor variations may apply to individual settings, please check our fee sheet for more information). Our all-inclusive package includes all enhanced art and craft materials, drinks, a healthy breakfast, hot lunch (nursery dependant) and snacks, outings, funding and admin support, equipment, and resources over and above the basic provision.

We accept Early Education Funding of up to 1140 hours per year for all eligible working families of children aged between 9 months and 4 years. In order to access a government funded place, a valid working parent funding code must be obtained prior to the governments application deadline.

In addition, we have a limited number of fully funded places for 2-year-olds from families receiving additional support. These are subject to availability and are offered on a first come first served basis with a maximum of 570 hours available per year. A Local Authority funding code is required in order to access one of these places.

In order for children to receive the care and education they need to be 'school ready' all 3/4 year-old's are entitled to up to 570 hours of Early Education Funding each academic year. We have a limited number of fully funded term-time only places, which are subject to availability.

All Early Education Funding is claimed throughout the year, on a term by term basis.

Funded hours are offered in line with the Early Years Foundation Stage statutory framework with the option to include all healthy meals, including breakfast, hot lunch (nursery dependant) and snacks, drinks, personal care items and enhanced resources/activities at an additional cost. The additional cost's for funded hours are referred to in our Consumables Package.

Your All-Inclusive Package Account

Your account requires a completed booking pattern upon registration, but we provide the opportunity to amend your bookings, if necessary, via a PERMANENT WEEKLY BOOKING (PWB)/PERMANENT TERMLY BOOKING (PTB) form.

To ensure your child's time at nursery/preschool/play club is settled and happy, our minimum booking requirement is 2 x 5-hour sessions per week (on separate days).

For parents/carers claiming funding we require one fixed booking pattern per term (Jan-Mar, Apr-Aug, Sept-Dec). If you wish to change your termly booking pattern please submit your new PWB/PTB form to the Admin Team by the 10th of the month prior to the term e.g. by 10th December for January-March term. Additional bookings for non-funded sessions may be submitted at any time via the Ovio App and are subject to availability.

For parents/carers NOT claiming funding we allow monthly amended bookings - please submit these via email to admin@sunnydays.co.uk by the 10th of the month for the following month e.g. before 10th January for February changes. Additional bookings may be submitted at any time via the Ovio App and are subject to availability.
